
Instructions & warranty

## **WELCOME TO THE FIRSTBEAT BODYGUARD 2!**

Firstbeat Bodyguard 2 is a reliable R-R interval and movement data recording device for short and long-term measurements. Bodyguard 2 is designed for round-the-clock recordings and can be used during exercise, leisure time and sleep. Be sure to follow these instructions to ensure reliable, high-quality measurements.

## **BEFORE THE MEASUREMENT**

- Charge the Firstbeat Bodyguard 2 by attaching it to your computer's USB port. Detach the cable to reveal the USB connector.
- Charge the device fully. Charging will begin automatically. When doing this for the first time, it may take a few minutes for charging to begin.
- 3. Ensure that the computer is connected to the power network throughout the charging process.



# SIGNAL LIGHTS WHILE ATTACHED TO THE USB PORT

Orange LED is flashing once per second.
 The battery is charging.

Orange LED shines continuously.
 The battery is fully charged.

Green LED shines continuously.
Bodyguard 2 is in communication with the computer.

Green LED is flashing rapidly.
 Reading measurement data.

Red LED is flashing or shining
 Error, try to re-attach the device to USB-port.
 If problem continues please see FAQ.

- 4. When using the Bodyguard device for the first time, prepare it with Firstbeat software. Note! When using the device for the first time with Firstbeat Lifestyle Assessment, please install a Firstbeat plugin. The plugin is not required with Firstbeat Sports. For further information on plugin installation, please visit Firstbeat Help Center at firstbeat.com/bg.
- 5. When the device is prepared and the battery is fully charged, detach the device from your computer and re-attach the cable to the device. Note! Make sure the cable is re-attached in the right way and snaps fully into place. See image below.
- 6. The device is now ready for a measurement.




# MEASUREMENT CONTRAINDICATIONS


In the following situations, conducting a measurement is either forbidden or not recommended:

- In some industrial areas requiring ATEX approval, it is forbidden to use heart rate devices without separate ATEX approval.
- In some sports, the rules may ban the use of heart rate devices (e.g. martial arts and some team sports). Using the device in competitions needs to be confirmed with a referee / official.
- If the client has a pacemaker or heart transplant.


# DURING THE MEASUREMENT ATTACHING AND USING THE DEVICE




1. Attach the electrodes to the snaps in the Bodyguard 2 device.



3. Attach the device to the **right** side of the body below the collar bone. The other end is attached to the **left** side on the rib cage.



2. Remove the protective covering of the electrodes. Ensure that your skin is dry before you attach the electrode. Shave off body hair from attachment sites.



4. The measurement starts automatically when the device is attached. Make sure the green light is blinking. Note! The light is easiest to see in the dark.

It is not allowed to use the device in the water. Detach the device during shower, sauna and swimming. The measurement continues automatically when you re-attach it. The electrodes are disposable. Change them at least once per day, for example after taking a shower or if they become loose during the measurement. The adhesive in the electrodes can occasionally cause skin irritation. # SIGNAL LIGHTS DURING A MEASUREMENT

	Green LED is flashing in sync with the heart rate.	Bodyguard 2 is recording heartbeat data.
	Green and orange LEDs are flashing simultaneously.	Bodyguard 2 is recording but the battery is low. Continue measuring but if you are in the middle of your measurement period, please get in touch with your contact person.
•	Red LED is flashing or shining continuously.	Bodyguard's memory is full or the battery has died. Discontinue the measurement and recharge and/or clear the device memory.

# AFTER THE MEASUREMENT

- 1. Attach the Firstbeat Bodyguard 2 to the computer's USB port.
- 2. Upload the measurement data from the device with compatible Firstbeat software.
- 3. Charge the battery after measurement. Please note! Device is best to store with a fully charged battery. This shortens preparation time during subsequent measurements and extends battery lifetime. The battery may malfunction or experience reduced capacity if device is stored with empty battery over 3 months.
- 4. Clean the device with a damp towel and non-alcoholic detergent. Re-attach the cable before cleaning. Do not use a wet towel or detergent that contains alcohol.
- 5. Detach the cable for storing.

### PLEASE ALSO NOTE THE FOLLOWING:

- To ensure electrical safety, the device must not be connected to a computer when attached to a person.
- Attach the device to the computer's USB port to recharge the battery. The charging begins
  automatically. Multiple devices can be recharged simultaneously in a USB hub that is
  connected straight to the power network.
- Do not recharge multiple devices in a USB hub that is connected to the computer's USB port because all devices might not charge fully. Do not store fully charged devices in a USB hub!

# **AVOIDING SKIN IRRITATION**

During the measurement, some skin irritation can occur. On the rare occasions this does happen, it is usually temporary skin irritation that typically lasts for a few days.

The electrode's adhesive or conduct gel can cause skin irritation, but it can also be caused by the user: Poor skin hygiene, mechanical stress when removing electrodes or long-term use can have an impact.

To avoid skin irritation during measurement, please follow these steps carefully:

- Clean the electrode placement spots on the skin (below right clavicle and left rib-cage) before attaching electrodes especially if there is sweat or some impurity.
- Add a thin layer of non-greasy basic lotion to the spots where you are going to attach the
  electrodes.
- Let the basic lotion dry out thoroughly (at least 10 min) to avoid electrode contact problems to the skin.
- Also, when removing electrodes, it's recommended to apply a few drops of water to avoid
  mechanical stress to the skin. Remember to change the electrode's placement on the skin
  during replacement of the electrode.
- Repeat all steps each time you attach new electrodes.

In case of serious skin irritation, we recommend stopping the measurement and contacting your service provider for further instructions.

# FIRSTBEAT BODYGUARD2™ PRODUCT SUPPORT AND LIMITED WARRANTY

#### 1. GUIDELINES FOR USE, MAINTENANCE AND DISPOSAL

#### 1.1. PURPOSE OF USE

- FIRSTBEAT BODYGUARD2™ ("Product") is a measurement device for heartbeat monitoring and recording.
- Product is designated for the needs of well-being and fitness professionals.
- · Product enables easy, reliable and continuous daily heartbeat monitoring and recording.

#### 1.2. INSTRUCTIONS FOR CHARGING

- . Do not charge the Product while attached directly to the skin.
- Use only compatible charging devices. Product may not be compatible with all of the USB-cables on the market.
- Product battery is rechargeable via compatible USB-cable attached on computer's USB-port.

#### 1.3. STORAGE AND USE OF THE PRODUCT

- Keep the Product in dry and average room temperature. Store the Product in a soft storage/case when possible.
- Do not keep or store the Product next, or near to, any other power supplies or magnetic fields.
- . Do not pull, tie or knot the cable on the Product.
- . Do not attach the Product on any other surface than to the skin of chest.
- Product cannot be used while passing security checks at airports or any other facilities.
- Product is not recommended to be used together with a pacemaker.
- Product use is forbidden in the facilities, where the use of electronic devices is forbidden.

#### 1.4. FURTHER SAFETY INFORMATION

- Product is not waterproof. Do not use the Product in water or during a shower or sauna.
- The cable on the Product must be connected while using the Product.
- Adhesive gel on the patch sensors of the Product may cause skin irritation. Make sure the skin is carefully cleaned after every use.
- In case an allergic reaction of any kind is noticed during, or after the use of the Product, the use of the Product must be stopped immediately and the skin cleaned thoroughly. In case needed, medical advice of a doctor shall be requested.
- CE-standards: Product is CE marked and complies with the requirements of Electromagnetic Compatibility (EMC) Legislation: Directive 2004/108/EC.
- FCC-standards: Product is tested and complies with the FCC technical standards for digital devices: Class B digital device, FCC Part 15. The Product products, operates and may generate electromagnetic radiation that may cause a disruption on radio communication. Disruption-free use cannot be guaranteed. In case the Product causes disruption

on any other devices, the problem may be remediable by relocating the Product. Contact Firstbeat in case continuous problems are noticed.

- Conditions for the use: (1) Product cannot cause detrimental or harmful disruptions (2) Product must process and accept also all of the received disruptions, also the ones that may cause the Product malfunction. Product is FCC certificated.
- WARNING RELATING TO FCC CERTIFICATION: Any alterations or modifications of any kind of the Product, and not explicitly accepted by Firstbeat, may invalidate the right to use the Product in accordance with the FCC certification.

#### 1.5. PRODUCT MAINTENANCE AND CLEANING

- Cleaning of the Product in accordance with the instructions provided by Firstbeat is the only maintenance measure permitted for the Purchaser. Other maintaining measures or fixing of the Product are not permitted.
- Product must be cleaned every time passing it on the user. In case the Product is unclean after the return, it is recommended to clean it immediately.
- Product must be removed from a computer before and during the cleaning, the cable of the Product must be connected. Leaving the cable open during the cleaning will cause the breakage of the Product by electrolytic oxidation.
- Product and the cable shall be cleaned by gentle scouring with a damp cloth moistened with a hint of water and alcohol-free cleaner.
- . Use of running water or overly wet cloth is not permitted.
- Use of alcohol-contained cleaners is not recommended.

## DISPOSAL

Please dispose the Product by following recycling orders and recommendations provided for electronic products. Do not dispose the Product by mixing it with other domestic refuse. In case desired, the Product can be sent to Firstbeat for disposal.



#### 2. LIMITED WARRANTY

#### 2.1. WARRANTY PERIOD

- This limited warranty ("Warranty") covers the Product FIRSTBEAT BODYGUARD2™ heartbeat recording and measurement device exclusively.
- Warranty covers a limited Warranty period of one (1) year. The Warranty period starts at the date of original purchase. No repair or replacement will renew or extend the Warranty period.
- The date of the original purchase can be evidenced by the proof of purchase and the readable serial number of the Product issued by Firstbeat.

#### 2.2 WARRANTY COVERAGE EXCLUSIONS AND LIMITATIONS

- Warranty will apply for defects in materials and workmanship, the functionality of the Product software and battery.
- Warranty provides that each Product will be free from substantial faults or defects in material and workmanship at the time of purchase, or substantial faults or defects which may appear during the Warranty period provided that the Product is used, cleaned and maintained
- properly and always in accordance with the guidelines provided in Section 1 "GUIDELINES FOR USE,
- MAINTENANCE AND DISPOSAL".
- Warranty is invalidated if the defect is caused by misuse, neglect, and tampering or incorrect adjustment, including, but not limited to, the breakage of the plastic cover or the cable, any measures contrary to the guidelines provided in Section 1 "GUIDELINES FOR USE, MAINTENANCE AND DISPOSAL" or other instructions for proper use provided by Firstheat.
- Firstbeat's obligations under this Warranty are limited, at its discretion and cost, to either fixing or replacing the
  Product it determines was defective at the time of the purchase or during the Warranty period, without undue delay,
  and against a valid claim made in accordance with Section 2.3. "ACCESS TO WARRANTY" within reasonable time after
  noticing the issue. In any event, the valid claim must be made prior to the termination of the Warranty period.
- Claiming party shall cooperate with Firstbeat in providing any additional information as may be required to
  investigate a valid claim, including shipping the Product back to Firstbeat, if so requested. In case shipping is required,
  claiming party will defray the costs of the shipping.
- The Warranty shall not apply and Firstbeat shall not be liable for
  - 1) ordinary wear and tear;
  - 2) neglect, accident, improper or unreasonable use, storage, installation or maintenance of the Product, and defects, damages,
  - losses and costs resulting from these actions by purchaser, end user or third parties;
  - 3) Products that have been altered, modified, repaired, opened or tampered with anyone else than Firstbeat;
  - 4) cleaning and washing the adhesive patch sensors of the Product with any other cleaner except the cleaner instructed and advised in the user manual or any other document provided with the Product;
  - 5) use of the Product contrary to their respective documentation, user manuals and instructions, or in a nonconformable operational environment, including defects resulting from use of third party technology in connection with Products:
  - 6) damage caused by hacking, cracking, viruses, or other malware:
  - 7) accident, fire, power-failure, power surge or other hazard; or
  - 8) any parts, which may have reduced capacity as a result of the natural end-of-life processes shorter than the Warranty period (including, batteries and Ambu BlueSensor L electrodes).
- Except as expressly required by mandatory law, the Warranty granted herein is construed with and interpreted in
  accordance with the laws of Finland. In any event the Warranty will be limited to the countries where the Product has
  been initially marketed.
- NOTE: THIS WARRANTY DOES NOT AFFECT THE RIGHTS OF THE CONSUMER VALID, IN FORCE AND IN
   ACCORDANCE WITH THE MANDATORY PROVISIONS OF THE NATIONAL LEGISLATION, AND THE RIGHTS OF THE
   CUISTOMER TOWARDS THE RESELLER PURSUANT TO THE PURCHASE/SALE AGREEMENT.

- In case of any conflict between the terms and conditions displayed herein and the documentation in the sales
  package of the Product, the terms and conditions included in the sales package shall prevail. Despite of the foregoing,
  the Product purchaser, end user and third parties must, at all times, comply with all guidelines and instructions provided
  with the Product for its proper use.
- To the extent permitted by applicable law, Firstbeat's liability shall be limited to the purchase value of the Product.

EXCEPT AS SPECIFIED IN THIS WARRANTY, ALL EXPRESS OR IMPLIED CONDITIONS, REPRESENTATIONS, AND WARRANTIES INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OR CONDITION OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NONINFRINGEMENT, SATISFACTORY QUALITY OR ARISING FROM A COURSE OF DEALING, LAW, USAGE, OR TRADE PRACTISE ARE HEREBY EXCLUDED TO THE EXTENT ALLOWED BY APPLICABLE LAW. IN NO RESPECT SHALL FIRSTBEAT BE LIABLE OF ANY DAMAGES, INCLUDING, BUT NOT LIMITED TO DIRECT, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES RESULTING FROM THE PRODUCT OR THE USE OF THE PRODUCT, WHETHER OR NOT BASED UPON THE WARRANTY; OR WHETHER OR NOT INJURY WAS SUSTAINED BY PERSON OR PROPERTY; OR SUSTAINED BY A THIRD PARTY.

#### 2.3 ACCESS TO WARRANTY

- Claim of a defect or malfunction covered by this Warranty must be performed to Firstbeat's product support. For the
  product support and replacement measures, the service requires as detailed as possible description of the defect, date
  and place of the original purchase and the contact details of the purchaser (name, address and telephone number).
- In case of a defect or malfunction, contact Firstbeat, by filling in a form of product support request at the website: https://www.firstbeat.com/en/support/report-a-faulty-device/
- Firstbeat will contact the purchaser after receiving the valid claim. Firstbeat will provide the purchaser with further advice and instructions.
- Non-binding target duration for the Product maintenance is five (5) workdays from the day when Firstbeat receives the Product from the purchaser.
- Please note that all back up data and content should be stored, or received from the Product, before taking the Product in for Warranty service, since Warranty service activities may erase data from the Product.

Never try to fix the Product yourself. Trying to fix the Product yourself will lead to the invalidation of the Warranty. Maintenance and repairing measures are always performed by Firstbeat.
